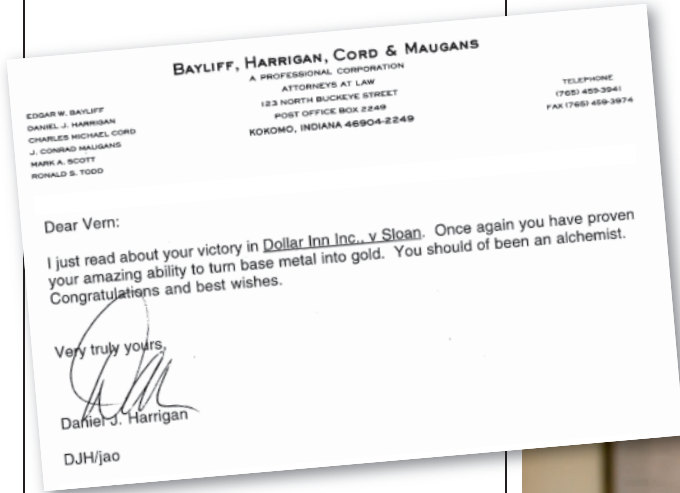

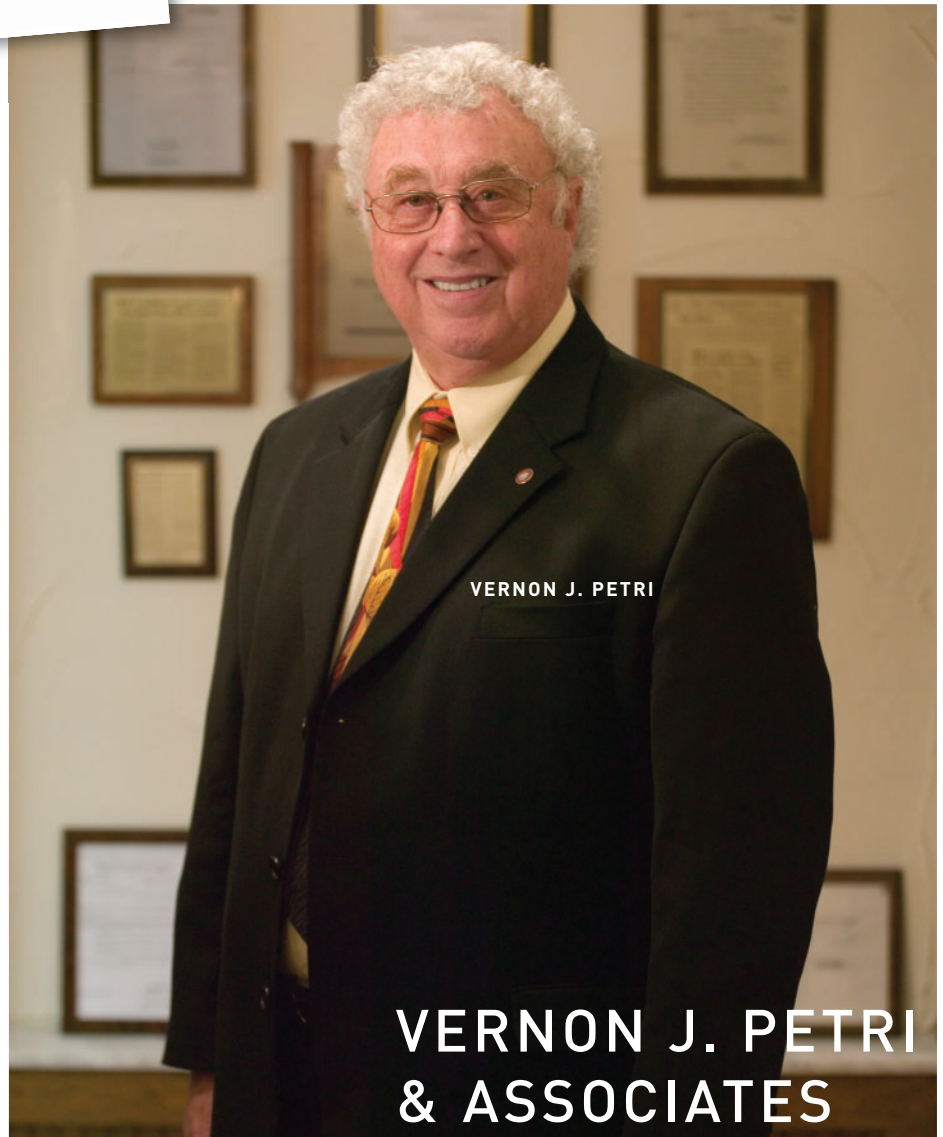

**WILLING TO TAKE
CASES ON PRINCIPLE
—NOT PRECEDENCE**

BREAKING NEW GROUND One of Petri's favorite cases involved a killer curve on the new I-70 that claimed the lives of 13 people, including his client's husband. Petri's investigation into the cause of the accidents resulted in the redesign of the curve, as well as a settlement for his client.

Another memorable case for Petri was one that involved a little girl who was scalded by tap water via a defective home hot water heater—one of the first cases of its kind. The American Trial Lawyers Association (ATLA) appointed him national chair of similar litigation. He also has won several pharmaceutical cases involving dangerous and defective drugs that caused the destruction of livers and kidneys and the subsequent deaths of people taking drugs. Petri was asked to take the lead in this type of litigation for ATLA as well.

Petri and his staff of lawyers handles hundreds of cases that involve medical injuries due to medical malpractice. He also serves on the executive committee of ATLA's Breast Implant Litigation Group.
